Deposit form is required to be filled out prior to deposit, Sales Contract is required to be signed emailed back to Breeder. Puppy Balance has to be paid by 6 weeks of age, if balance has not been paid puppy will go back up for sale and deposit remains with Breeder. Any Puppy left on premises past 10 weeks of age there will be a \$20.00 per day boarding fee, any medical or extra cost will be billed on the Puppy price.

Ear cropping payment is required to be paid by 6 weeks of age, all ear crops will be performed at 7 weeks of age, Breeder not responsible for ears standing up nor crop.

Buyer agrees all information provided is truthful, without misrepresentation, any false information given will null and void all contracts, all fund is then forfeited. Buyer Understands Puppy sales are only between Buyer and Breeder, there is no third parties involved with sale, or ownership of said puppy.

This is a binding agreement between Buyer and Seller, Buyer understands by signing this contract that the deposit is non-refundable.
